STATEMENT OF PROPOSAL

- 1. This collaboration is based on a proposal for the design and implementation of Indoor Navigation
 Assistance Solution to be implemented at Kamala Nehru College Campus, University of Delhi
- This research project would be based on a pilot installation and study to be carried out in the Ground,
 First and Second floors of the Main building at Kamala Nehru College.
- 3. From the elementary survey at various venues (i.e. hospitals, public buildings and academic institutions), it has been found that wayfinding is a challenge for people with disabilities, especially visual disability. Inadequate and non-strategic placement of signage also adds to this wayfinding challenge. It is further complicated for visitors who are not familiar with the local language and have limited visual sensory abilities.
- We believe a technology-based solution using smartphones would be able to address this challenge for people with a visual disability (PVDs) and will also be useful to mainstream users.
- An effective indoor wayfinding system depends on formulation of key components that includes: visual
 accessibility, actual and ideal path, decision points identification, strategic inclusion of essential
 information over map, cognitive map modeling of the facility.
- In this project, comprehensive digital mapping will include field survey, area division, information sourcing, mapping and its validation. Further, localization using bluetooth beacons to support real time indoor navigation is planned.
- 7. The key initial objective of this collaboration would be to understand the existing area division, flow patterns, navigation/wayfinding challenges as well as accessibility issues. The aim would be to implement a unique solution that can address the wayfinding challenges. Further, a gradual evolution eliminates the need for major adaptation and retraining requirements of major stakeholders.

IMPLEMENTATION PLAN

- Total duration of the project will be 12 months. The project will be implemented in two phases. Phase
 one will include creating an accessible digital map of the college campus venue. Duration of phase 1 will
 be 2 months. This includes division of area/zone based on their functioning like "Academic,
 Administrative, Classroom, Cafeteria and Lab-etc", field survey, information sourcing, validation and
 annotation over existing venue map.
- 2. Phase two will include identification of locations and installation of bluetooth beacons to support real time navigation. Combined with the annotated digital map in phase 1, this would help solve the independent and real time navigation challenge of all types of visitors keeping PVDs as the central focus. The duration for stage two will be 4 months after completion of phase 1. This phase will also include testing, refinement and validation of the system.
- Final validation reports will be generated including the inputs and feedback from users/students and
 the college staff after successful implementation of the navigation system. Assistech Lab will extend the
 support including service, maintenance and upgrades for 6 months after completion of phase 2.







