

Activities 2018

Crossfire, the English Debating Society, of Kamala Nehru College has performed exceedingly well during the academic session 2018-2019. Members won laurels at several prestigious debating tournaments. With rigorous training and extensive hard work, the society members participated as debaters and adjudicators in tournaments such as Mukerji Memorial Debating Tournament (St Stephen's College), Natasha Ranjan Memorial Debate (Jesus and Mary College), Premchand Memorial Debate (Hindu College), IIT-Delhi, Miranda House College, Ramjas College, Sri Venkateshwara among several others.

The student members also displayed a remarkable performance throughout the senior debating season. Our achievements began with Smriti Gupta, Vaishnavi Bhaskar and Damini Mehta reaching the Semi-Finals at People Speak (Sri Venkateshwara College). Uttam Kanwar qualified and went on to adjudicate till Semi-Finals as well. Uttam performed exceedingly well and adjudicated till the Semi Finals at Premchand (Hindu College). At Delhi College of Arts and Commerce, Vaishnavi, Damini and Heba Rahman went onto to reach the Quarterfinals. Vanshika Singh and Khushi Rajput, secured the positions of the Fourth Best Adjudicator and Fifth Best Adjudicator, respectively. Vaishnavi continued her stellar performance by winning the Second Best Adjudicator position at Taqreer (SSGGSC). At Indraprastha College for Women, Vanshika and Aeshita Sinha bagged the Second Best Adjudicator and Fourth Best Adjudicator positions, respectively.

At Deen Dyal Upadhyay College, a team comprising of Sanjula and Devanshi broke and went onto Quarterfinals. Nupur and Hemangi broke also broke as adjudicators.
